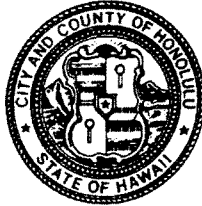

REMINDERS

PAYMENT OF CHARGES:

Charges not paid within 60 days shall become delinquent and shall be subject to interest at the rate of 1% per month for each month or fraction thereof that such charges remain delinquent.

FAILURE TO PAY CHARGES:

Collection and disposal service to any business shall be discontinued for failure to pay any charge when due. There shall be a service reinstatement fee of \$10.00, which shall be paid to the Director of Budget and Fiscal Services at the time request for reinstatement of service is made. A service fee will be charged for handling a dishonored check.
